Actions to be taken for **New Registration**:

1. Parent/ Guardian completes the registration form & fee
  - a. Return registration form along with Registration Fee to Advancement Director.
  - b. Required: completing a FACTS Registration
    - i. Secure an Agreement Number (from FACTS)
    - ii. Pay the FACTS Fee
2. SJRS will verify completeness of registration
3. Parent/Guardian completes the Grant and Aid portion of FACTS (deadline April 30th)
4. SJRS notifies families through FACTs Management System of Scholarship Grants awarded (by July 1<sup>st</sup>)

## FACTS REGISTRATION

### NEW SJRS FAMILY

After registering at St. Jerome Regional School, you need to create an online account with FACTS Management for processing your child(ren)'s SJRS tuition payments.

To create FACTS online account, go to <https://online.factsmgt.com/signin/3NYCY>

Create a new account using a username & password.

When you have created an account you must:

Set up a payment plan

Select a payment plan option

Enter payment details- account to be used for payment

Always log off when finished to protect your personal and financial information.

### EXISTING SJRS FAMILY

If you are registering for a new school year, you DO NOT GET A NEW ACCOUNT. Your information will be transferred to the new year.

You will need to update payment details and provide financial information for scholarship application.

Always log off when finished to protect your personal and financial information.

### SCHOLARSHIP APPLICATION

To be considered for any scholarships, which are based on financial need of the family, you must:

1. Have completed the FACTS registration and selected a payment plan.
2. Complete the Grant and Aid application in FACTS. **This data must be entered by April 30<sup>th</sup>.**
3. Submit FACTs nonrefundable application fee payment
4. Submit as required, tax returns and forms
5. Verify with FACTs that all forms were received
6. Have **NO TUITION BALANCE REMAINING AT THE END OF THE CURRENT SCHOOL YEAR**

Preliminary scholarship awards are provided by July 1<sup>st</sup>

## TRANSFER GRANTS

St. Jerome Regional School provides grants to students that are transferring from public schools or non-Catholic schools into the 1<sup>st</sup> thru 7<sup>th</sup> grades. Students that previously attended SJRS or another Catholic elementary school is not eligible.

Amount-

\$500 is provided for the **first year** of the student transfer,

\$500 is provided for the **second** consecutive year.

Eligibility-

1. Transferring from a non-Catholic school  
and
2. Entering 1<sup>st</sup> to 7<sup>th</sup> grade  
and
3. Never previously attended a Catholic Elementary School.

**Grant is only provided when family does not have an outstanding tuition balance with SJRS.**

**Parents must maintain payment schedule to retain transfer grant.**

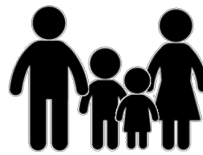

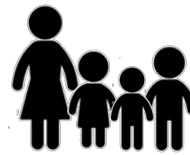

Scholarships and Grants are available for families to assist with tuition payments for K- 8 students and are awarded based on demonstrated financial need.

Requirements:

Parent must complete FACTS registration (Create Payment Agreement) by April 1<sup>st</sup>

Parent must complete Grant and Aid application in FACTS by April 30<sup>th</sup>

Must be registered in St. Jerome Regional School- Kindergarten through Eighth Grade.

**Family cannot have an outstanding tuition balance with SJRS.**

**Family must maintain payment schedule to retain scholarships and grants.**

Pre-kindergarten students who are three or four years old may qualify for the limited separately funded Pre-K program

Actual scholarship is awarded when funds are received from the Eastern Pennsylvania Scholarship Foundation. Amount of scholarship is dependent on the financial need demonstrated from the previous year income tax returns submitted and entered into the FACTS system. Scholarships are awarded only through the FACTS system, after families have met the Grant and Aid application deadline and the income guidelines.

**\*\*\*Parents are expected to pay tuition on the pre-scholarship basis until scholarships are awarded. Payment amounts are adjusted when the scholarship is received\*\*\***
