Actions to be taken for **New Registration**:

- Parent/ Guardian completes the registration form and fee
- Return registration form along with registration fee to Advancement Director
- Complete STS Registration
- SJRS will verify completeness of registration
- Parent/Guardian completes the Grant and Aid application. (deadline April 30)
- SJRS notifies families through STS of Scholarship Grants awarded (by July 1st)

- Apr 30 Deadline for Financial Aid applications
- May 30 Deadline for final payments of current school year tuition
- July 1/15 First payment for 11 month payment plans
- July 1 Announcement of scholarship allocations for upcoming school year
- July 15 Deadline for full payment 4% discount
Deadline for 1st payment 2% discount ½ tuition
- Sept 15 First payment for the Preschool 9 month payment plans
- Dec 15 Deadline for 2nd payment 2% discount ½ tuition

STS REGISTRATION

After registering at St. Jerome Regional School, you need to create an online account with STS for processing your child(ren)'s SJRS tuition payments. To create an STS online account, go to <https://app.simpletuitionsolutions.org/register?sc=20359>

When you have created an account you must:

- Set up a payment plan
- Select a payment plan option
- Enter payment details- account to be used for payment

Always log off when finished to protect your personal and financial information.

SCHOLARSHIP APPLICATION

To be considered for any scholarships, which are based on financial need of the family, you must:

- Have completed the STS registration and selected a payment plan.
- Complete the Grant and Aid application in STS. **This data must be entered by April 30.**
- Submit STS nonrefundable application fee payment.
- Submit as required, tax returns and forms
- Verify with STS that all forms were received
- Have **NO TUITION BALANCE REMAINING AT THE END OF THE CURRENT SCHOOL YEAR**

Preliminary scholarship awards are provided by July 1st

SCHOLARSHIPS & GRANTS

Scholarships and Grants are available for families to assist with tuition payments for K- 8 students and are awarded based on demonstrated financial need.

Requirements:

- Parent must complete STS registration by April 30.
- Parent must complete Grant and Aid application in STS by April 30.
- Must be registered in St. Jerome Regional School- Kindergarten through Eighth Grade.
- **Family cannot have an outstanding tuition balance with SJRS.**
- **Family must maintain payment schedule to retain scholarships and grants.**
- Pre-kindergarten students who are three or four years old may qualify for the limited separately funded Pre-K program

Actual scholarship is awarded when funds are received from the Eastern Pennsylvania Scholarship Foundation. Amount of scholarship is dependent on the financial need demonstrated from the previous year income tax returns submitted and entered into the FACTS system. Scholarships are awarded only through the STS system, after families have met the Grant and Aid application deadline and the income guidelines.

*****Parents are expected to pay tuition on the pre-scholarship basis until scholarships are awarded. Payment amounts are adjusted when the scholarship is received*****
